Policy: SUPERINTENDENT OF THE YEAR AWARD

It shall be the policy of the Idaho School Superintendents' Association (ISSA) to recognize an outstanding individual who is on the frontier of educational leadership in the State. In cooperation with the American Association of School Administrators (AASA), this recognition program is dedicated to the potential and promise of public education in our democracy - that all children have access to a quality education, and that the riches and advantages of education benefit every child.

1. Award nomination and application submission timeframes shall be established by IASA staff in consideration of AASA timeframes, ISSA Board of Directors meeting dates, and IASA Annual Conference dates.
2. Award nomination shall be limited to practicing Idaho superintendents who meet the following criteria:
 - a. The nominee must be an active superintendent in Idaho for 3 years or more,
 - b. The nominee must be a current member of ISSA/AASA, and
 - c. The nominee intends to maintain ISSA/AASA membership during the year in which the award is received.
3. Nominations for the award shall be made on a form supplied by ISSA. Any person or group may submit a nomination.
4. IASA staff will notify nominees who meet the selection criteria of their nomination and the selection process, and staff will provide the nominee with the AASA application.
5. The submitted applications will be reviewed by the ISSA Board of Directors at their fall meeting. An award recipient will be selected, taking AASA award selection criteria into consideration. If a regional representative has submitted an application, the region will send a representative to the meeting to participate in the award selection. If an officer has submitted an application, no representative will be added to participate in the award selection.
6. Any application not previously submitted will be considered by the Board during the next year's application review cycle, provided the applicant continues to meet the award nomination criteria.
7. The award recipient shall be recognized at the Association's next annual conference and presented with an appropriate commemorative item. The ISSA will also provide up to \$1,500 in expense reimbursement for travel to the AASA Superintendent of the Year program in accordance with IASA Travel Policy and subject to ISSA budgetary constraints.
8. In the event that the award recipient is unable to fulfill the terms of the award including any duties, responsibilities and award ceremonies associated with the award, the ISSA Board may withdraw the award and designate the runner-up nominee as the award recipient.
